A request by Avenir Holdings, LLC for site plan approval for the 391-acre Panther National Master Plan comprising of 218 single-family residential units, a private golf course with clubhouse, a lifestyle center, maintenance facility, and a sales center within the residential parcel (Parcel A) of the Avenir Planned Community Development (PCD).
