The Palm Beach County's Canvassing Board has duly canvassed the returns of the March 15, 2016, Election and has certified the foregoing as true and correct tabulations of the total recorded and absentee votes cast. The Palm Beach County's Canvassing Board certified the results of the March 15, 2016, Election as follows:

TOTAL RECORDED AND ABSENTEE BALLOTS CAST – Group 2 = 9,976

TOTAL RECORDED AND ABSENTEE BALLOTS CAST – Group 4 = 12,898

~~Kevin Easton – 1,103~~ withdrew effective February 5, 2016

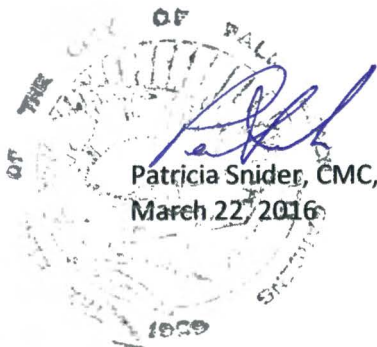
