**BACKGROUND:** The City of Palm Beach Gardens' Code of Ordinances ("Code") describes the composition of the Budget Oversight Review Board ("BORB") and sets forth the procedures for filling vacancies.

Section 2-128 of the Code provides for a total of five members who must possess considerable experience in a financial-related discipline, such as banking, finance/accounting, management/management consulting, or be a small-business owner.

Section 2-86 of the Code sets forth the procedures for filling vacancies. These procedures require the City Clerk to place on the Council agenda the list of volunteers, including current members who seek reappointment, with their attendance records.

On February 9, 2017, Council approved Ordinance 5, 2017, dissolving the Budget Oversight Committee ("BOC") and replacing it with the BORB. On May 4, 2017, Council approved Resolution 34, 2017, reaffirming three regular members of the dissolved BOC as regular members of the BORB. These three members' terms expired on February 8, 2020, which was three years from the date of establishment of the BORB.

When the BORB was created, there were also two vacant positions on the BOC. The two regular members filling these vacancies were appointed to three-year terms with the approval of Resolution 34, 2017, with terms expiring on May 3, 2020.

With the approval of Resolution 17, 2020, all five regular members of the BORB will serve three-year terms that will expire on May 6, 2023.

**STAFF RECOMMENDATION:** Staff recommends approval of Resolution 17, 2020 as presented.

## RESOLUTION 17, 2020

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALM BEACH GARDENS, FLORIDA, APPROVING THE APPOINTMENT OF REGULAR MEMBERS TO THE BUDGET OVERSIGHT REVIEW BOARD; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, Section 2-128 of the City Code of Ordinances requires the Board to be comprised of five regular members; and

WHEREAS, three regular member terms expired February 8, 2020; and

WHEREAS, two regular member terms expired May 3, 2020; and

WHEREAS, notice of the vacancies has been posted at City Hall and on the City website; and

WHEREAS, the City Clerk has collected applications of all interested persons who wish to serve as members of the Board, along with attendance records of the current members, which are attached hereto as Exhibit "B"; and

WHEREAS, the City Council deems approval of this Resolution to be in the best interests of the health, safety, and welfare of the residents and citizens of the City of Palm Beach Gardens and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PALM BEACH GARDENS, FLORIDA, that:

SECTION 1. The foregoing recitals are hereby affirmed and ratified.

<u>SECTION 2.</u> The City Council hereby approves the appointment of five regular members to the Budget Oversight Review Board as set forth in Exhibit "A."

**SECTION 3.** This Resolution shall become effective immediately upon adoption.
