1. Recommendation to City Council (Public Hearing) – QUASI-JUDICIAL HEARING SPLA-22-03-000063 - Frenchman's Creek requests a site plan amendment for a new 93,155 SF Clubhouse along with 12,451 SF of outdoor dining area

A request by Frenchman's Creek Inc. to construct a new 93,155-square-foot clubhouse building and parking lot within the Frenchman's Creek Planned Community Development (PCD). The property is located on the southeast corner of the intersection of Donald Ross Road and Alternate A1A.
